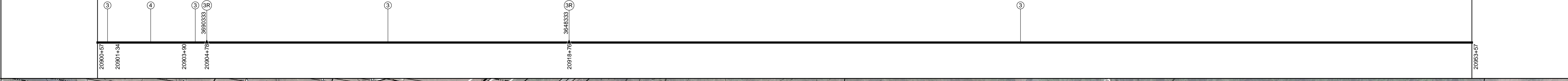
CLASS LOCATION

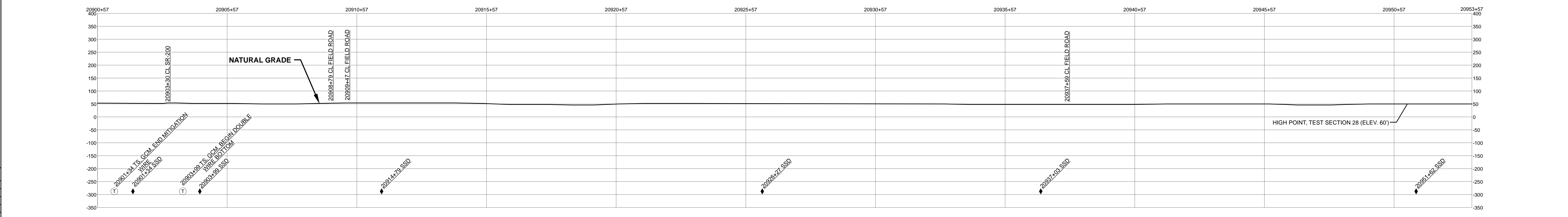
