



Signs identified in this section may be placed without a permit, provided that such signs comply with the standards in Table 5.04.05.

**Table 5.04.05. Standards for Provisionally Exempt signs.**

<b>Identification signs, including parking identification signs</b>	<u>Auto-oriented Entrances:</u> <ul style="list-style-type: none"> <li>• <u>Five (5) s.f. or less in area, and</u></li> <li>• <u>Maximum height of three (3) feet</u></li> </ul> <u>Semi-truck Entrances:</u> <ul style="list-style-type: none"> <li>• <u>Eight (8) s.f. or less in area, and</u></li> <li>• <u>Maximum height of five (5) feet.</u></li> <li>• <del>No individual letters, symbols, logos, or designs in excess of eight (8) inches in vertical or horizontal dimension</del></li> </ul>

<b>Menu/<del>preview</del> boards or price lists for drive-through facilities</b>	<ul style="list-style-type: none"> <li>• <u>Maximum of two (2) such boards per drive-thru lane, and</u></li> <li>• <u>Maximum area of <del>twenty-four (24)</del> <u>sixty (60)</u> s.f. per board or less and a maximum of one hundred s.f. (100) per drive thru lane, and</u></li> <li>• <u>Located adjacent to and oriented toward for visibility only within the drive-through thru area(s)</u></li> </ul>
<b>Real estate signs</b>	<ul style="list-style-type: none"> <li>• <b>Sixteen (16) s.f. or less in area in R-10, R-21 and R-1 zoning districts, or</b></li> <li>• <b>Thirty-two (32) s.f. or less in all other zoning districts, and</b></li> <li>• <b>Located on property for sale or rent, and</b></li> <li>• <b>Located only during the period of offering for sale or rent</b></li> </ul>
<b>Construction signs</b>	<ul style="list-style-type: none"> <li>• <b>Sixteen (16) s.f. or less in area in R-10, R-21 and R-1 zoning districts, or</b></li> <li>• <b>Thirty-two (32) s.f. or less in all other zoning districts, and</b></li> <li>• <b>Located on property where a valid building permit has been issued and has not expired</b></li> </ul>
<b>Yard or Garage sale signs</b>	<ul style="list-style-type: none"> <li>• <b>Eight (8) s.f. or less in area, and</b></li> <li>• <b>Located on the property on which a sale is being conducted, and</b></li> <li>• <b>Limited to the period of the sale, but not to exceed two (2) weeks per year per lot</b></li> </ul>
<b>Occupant or owner identification sign</b>	<ul style="list-style-type: none"> <li>• <b>Four (4) s.f. or less in area when located in a residential zoning district</b></li> </ul>
<b>Pennants</b>	<ul style="list-style-type: none"> <li>• <b>Individual pennants shall not exceed twelve (12) inches on any one (1) side. The length of</b></li> </ul>
