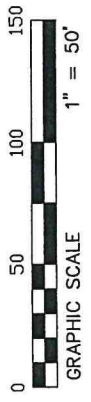


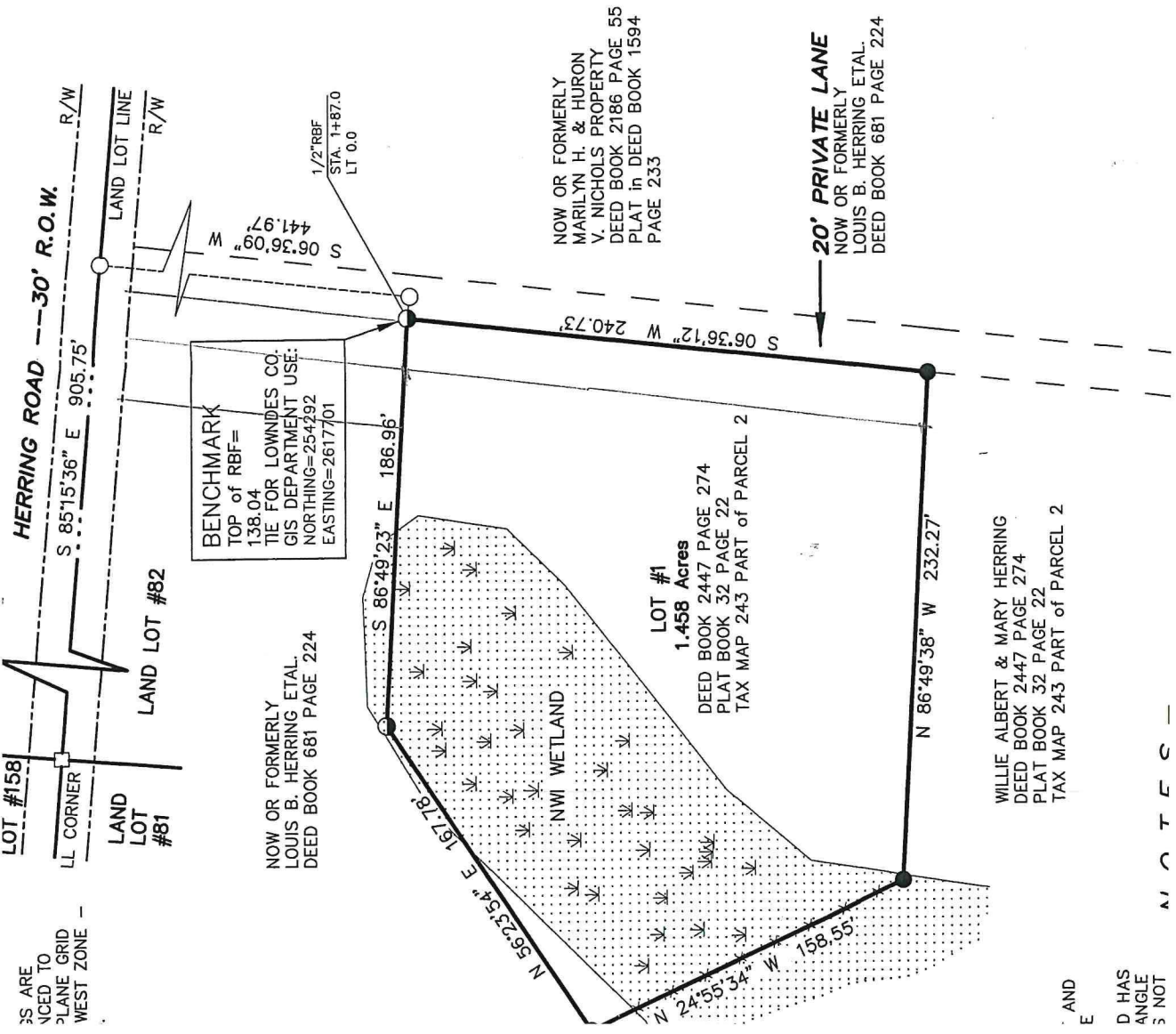
PLAT OF BOUNDARY RETRACEMENT SURVEY
