For a POINT OF REFERENCE, begin at a point marking the intersection of the projected southerly right-of-way (r/w) line of Deercrest Drive (said road having a 50' r/w) and the westerly r/w line of Springruff Drive (said road having a 50' r/w), and proceed thence S 10° 00' 32" W for a distance of 20.00 feet to a point located on the westerly r/w line of Springruff Drive; thence along said westerly r/w line of Springruff Drive S 10° 00' 32" W for a distance of 41.21 feet to a point; thence along said rw line along the arc of a curve to the left for a distance of 53.92 feet, said curve having a radius of 450.00 feet, and being subtended by a chord distance of 53.89 feet, with a chord bearing of S 13° 26' 30" E to a point, being the POINT OF BEGINNING; thence along said rw line along the arc of a curve to the left for a distance of 20.43 feet, said curve having a radius of 450.00 feet, and being subtended by a chord distance of 20.43 feet, with a chord bearing of S 18° 10' 30" E to a point; thence S 63°29'53" W a distance of 168.60 feet to a point; thence S 60°08'51" W a distance of 288.86' to a point located on the northerly rw line of Dockside Drive, (said road having a 50' r/w); thence along said r/w line along the arc of a curve to the left for a distance of 30.64 feet, said curve having a radius of 300.00 feet, and being subtended by a chord distance of 30.64 feet, with a chord bearing of N 43° 28' 20" W to a point; thence N 55°45'45" E a distance of 92.09 feet to a point; thence N 34°46'55" W a distance of 74.28 feet to a point; thence N 47°07'26" W a distance of 58.43 feet to a point; thence along the arc of a curve to the left for a distance of 32.01 feet, said curve having a radius of 1258.74 feet, and being subtended by a chord distance of 32.01 feet, with a chord bearing of N 86° 55' 44" E to a point; thence along the arc of a curve to the left for a distance of 65.96 feet, said curve having a radius of 1258.74 feet, and being subtended by a chord distance of 65.96 feet, with a chord bearing of N 84° 41' 57" E to a point; thence along the arc of a curve to the left for a distance of 66.38 feet, said curve having a radius of 1258.74 feet, and being subtended by a chord distance of 66.38 feet, with a chord bearing of N 81° 41' 14" E to a point; thence along the arc of a curve to the left for a distance of 5.13 feet, said curve having a radius of 1258.74 feet, and being subtended by a chord distance of 5.13 feet, with a chord bearing of N 80° 03' 36" E to a point: thence N 79°59'28" E a distance of 61.24 feet to a point; thence N 79°59'28" E a distance of 66.37 feet to a point; thence N 79°59'28" E a distance of 66.37 feet to a point; thence N 79°59'28" E a distance of 66.81 feet to the POINT OF BEGINNING.
